ORDER:

In the Government order read above, draft Notification has been issued to amend the proviso to sub-rule (3) of rule 91 of the Tamil Nadu Motor Vehicles Rules, 1989, exempting the members of the Tamil Nadu Legislative Assembly from payment of fee prescribed for allotment of advance numbers by the Government or the Registering Authority for registration of vehicles in their names, only one time during the course of the Assembly tenure as Member of the Legislative Assembly. In the said Notification, objections or suggestions were invited from the persons likely to be affected on the proposed amendment to the said Tamil Nadu Motor Vehicles Rules, 1989 and the said draft amendment to the said Rules, has been published in the Home Notification No. SRO A-29(a)/2007, dated the 20th July 2007 on page 1 of Part III – Section 1(a) of the Tamil Nadu Government Gazette Extraordinary, dated the 20th July 2007.

2) No representation has been received from any one on the above draft amendment published in the said Tamil Nadu Government

Gazette. The Government have therefore decided to confirm the draft amendment to the rule 91 of the Tamil Nadu Motor Vehicles Rules, 1989, published in the said Tamil Nadu Government Gazette Extraordinary, dated the 20th July 2007. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette Extraordinary, dated the 19th September 2007.

NOTIFICATION.

In exercise of the powers conferred by section 65 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Motor Vehicles Rules, 1989, the same having been previously published, as required by sub-section (1) of section 212 of the said Act.

AMENDMENT.

In the said Rules, in rule 91, for the proviso to sub- rule (3), the following proviso shall be substituted, namely :-

“Provided that Members of the Tamil Nadu Legislative Assembly shall be exempted from payment of fee prescribed for allotment of advance numbers by the Government or the Registering Authority for registration of vehicles in their names for one time only during the period of their tenure as Member of the Legislative Assembly.”
